DECLARATION

By the Association of Balkan Chambers

We, the members of the Association of Balkan Chambers having signed the declaration herein taking into account:

- the growing political and social tensions in the countries of Northern Africa and the Mediterranean region, which jeopardize the sustainable development of the Balkan region
- the efforts of the governments in the above-cited regions directed towards localizing the expansion of the conflict with democratic measures

And

- the increased activity of public authorities in the Balkan region to strengthen the cooperation between the countries

hereby INSIST on:

- Strengthening the centralized measures in neighbouring regions and their stabilization as well as
- Stepping up the measures taken by the governments against corruption and shadow economy in order to reduce them to tolerable levels;
- Reduction of administrative barriers and burdens, including state taxes to create more favourable environment for the economic development of entrepreneurship;
- Intensification of the work as to removing of tariff and non-tariff barriers;
- Further liberalization of trade in the region in accordance with the CEFTA agreement 2006
- Discontinuance of the increase of direct and indirect taxes and social security contributions, which trend has been observed in some Balkan countries;
- Implementation of efficient and effective programs to fight unemployment, the measure being especially important in the ongoing recovery from the economic crisis.

• Improvement and development of infrastructure in the region by implementing common regional projects /materialization and increasing the number of border crossings, railways and air transport facilities, etc./
