## **Erasmus programme for Young Entrepreneurs**

The European Commission, DG Enterprise and Industry, has recently launched a pilot project for an exchange programme for young entrepreneurs, aimed at equipping them with relevant skills for managing their new companies.

The 'Erasmus for Young Entrepreneurs' pilot project will provide 870 entrepreneurs with a grant to spend between one and six months in another EU Member State, learning from an experienced entrepreneur who is running an SME in the chosen country. With the help of local chambers of commerce and other intermediary organisations, people starting their own businesses will be paired up with established SMEs in other EU countries.

'Erasmus for Young Entrepreneurs' is part of the Small Business Act and its objective is to foster entrepreneurship, internationalisation and competitiveness of potential entrepreneurs and newly established micro and small enterprises in the EU. The pilot project should encourage more people to set up new businesses and boost the exploitation of commercial opportunities of the internal market. Currently, too few people in the EU establish new companies and only 8% of the existing European SMEs export goods and services to other EU countries.

## Experts' recommendations to avoid repeat of financial crisis.

A group of financial experts has put forward 18 detailed recommendations to strengthen supervision of the EU's financial institutions and markets. Recommendations include developing common rules for investment funds across all 27 EU Member States, capping bankers' bonuses in line with shareholder interests and establishing a crisis management system for the EU's financial sector. Two new EU control systems, one for financial supervision and another for managing risk, are also advocated.

The European Commission will give a first preliminary assessment and response to the main conclusions of the report already next week. The report will be also discussed at the spring summit of EU leaders.

# Latest Commission's reports on the implementation of legislation and practical problem-solving in the Internal Market

The Commission has recently issued three reports – Scoreboard, SOLVIT and Citizen Signpost Service (CSS) – as a package highlighting the close links between implementation of legislation and practical problem-solving in the Internal Market.

According to the latest Internal Market Scoreboard, Member States continue to perform well in implementing agreed Internal Market rules into national law on time. The Scoreboard's new chapter on the state of economic integration of the Internal Market demonstrates that enlargement can be seen as the major driver for further integration within the Internal Market, with most of the EU-10 Member States being very open to imports and direct investment from other Member States.

The analysis of CSS enquiries and SOLVIT cases provide a direct link to the difficulties citizens and businesses are experiencing and help to identify issues which may still need to be resolved in order to improve the operation of the Internal Market. In 2008 both services received a high number of requests in the areas of social security, professional qualifications and free movement of persons. Also, it is noticeable that late transposition or ineffective application of certain Internal Market rules tends to lead to an increase in the number of cases submitted to these services, for example in the areas of residence rights and professional qualifications.

## Future ICT and research innovation agenda: results of public consultation are online

From 4 September 2008 to 9 November 2008 the European Commission conducted an online public consultation on 'Shaping the ICT research and innovation agenda for the next decade'. The final report of this consultation has now been published and analyses 565 contributions from industry, ICT experts, policy-makers and the wider public. The results of the consultation will be fed into a renewed strategy for ICT research and innovation, to be unveiled in spring next year. The four main questions addressed to stakeholders were:

- 1. What are the main challenges ahead for ICT research and innovation? As the ICT revolution continues, what are Europe's key priorities for research and innovation?
- 2. How, and in what fields, should Europe aim to lead? Europe has world industrial and technological leaders in key fields such as telecommunications and embedded systems. How

can advances in these areas be reinforced and what new areas should a leadership profile be sought?

- 3. What is the role of public policy in putting Europe at the forefront of ICT innovation? How can research policy be consolidated to create a European market for ICT innovation? How can complementary policy fields such as standardisation, licensing and intellectual property regimes be adapted to support the early commercialisation of research results?
- 4. What features need to become available for Europe to adopt a more systemic approach for ICT?

The first European Maritime Day was celebrated in 2008 in Brussels. This year, the event is hosted by the Commission in partnership with the Italian Government. #### First review of the European Research Council to be initiated soon

After two years of operations, the European Research Council's (ERC) structure and mechanisms will be reviewed to analyse its achievements and develop strategies on the future direction of this pioneering research funding initiative.

The review will be conducted by a high-level panel of eminent representatives of science and policy from the European Union and the United States of America to be appointed by the Commission. The independent panel will meet between February and July and prepare an initial report this summer.

The ERC is internationally renowned for its European frontier research and, in its first two years, allocated more than 850 million Euros to 575 successful applicants. Currently, the ERC is managed by an independent Scientific Council and operates by implementing a structure that is to become an autonomous Executive Agency in summer 2009.
