Competitiveness Report 2008 available online

The European Commission has recently presented its "Competitiveness Report 2008", which takes into account the role of the following factors in boosting competitiveness:

- productivity differences and growth drivers;
- fostering trade openness and foreign direct investment;
- entrepreneurial initiative and small- and medium-sized enterprises (SMEs);
- opportunities arising from renewable energies and climate change policies;
- Corporate Social Responsibility (CSR).

Unfortunately, the report is overshadowed by the current economic downturn. However, the impact of the financial and economic crisis on Europe's economy highlights the relevance of the Growth and Jobs Strategy to boost competitiveness.

The Office for Harmonization of the Internal Market has launched new e-filing system

The Office for Harmonization of the Internal Market (OHIM) has launched its new Community trade mark online filing system (so called CTM e-filing system') on 2nd February 2009. The system is designed to be quick and simple to use. Its improved submission process will allow immediate confirmation, including the CTM application number and the generation of a receipt that the user can print or save. A short presentation and guidance to the new system are already available on the OHIM Web site so that the users can get acquainted with it.

2009 Marco Polo call for proposals published

The 2009 call for proposals for Marco Polo has been just published. Some € 62 million are available, supporting between 35% and 50% of the eligible project costs. Stakeholders in the freight transport or logistics business, i.e. commercial undertakings (possibly owned by public administrations) from the EU Member States, Norway, Iceland, Liechtenstein and potentially Croatia can apply.

The available funds are going to co-finance several projects in the following areas:

- <u>Modal shift actions</u> aiming at shifting as much freight as economically viable under current market conditions from road to short sea shipping, rail and inland waterways;
- <u>Catalyst actions</u> overcoming the structural market barriers in European freight transport through a highly innovative concept, which represents a real break-through;
- Motorways of the sea actions offering a door-to-door service, which shift freight from long road distances to a combination of short sea shipping and other modes of transport;
- <u>Traffic avoidance actions</u> integrating transport into production logistics so as to reduce freight transport demand by road, with a direct impact on emissions;
- <u>Common learning actions</u> enhancing knowledge in the freight logistics sector and foster advanced methods of co-operation in the freight market.

The deadline to submit project proposals is <u>8 May 2009</u>.

EuroTrans-Bio (ETB) is an initiative of some EU Member States and regions that aims to support trans-national research by coordinating national or regional public funding. The objective of this new call is to support SMEs and encourage their strategic partnerships. The ETB 4th Call is launched with the participation of 12 EU Countries and Regions. The call is generic and includes all fields of biotechnology.

Call for participants to training missions in Japan for EU manufacturers scheduled in June-July and October 2009

The EU-Japan Centre for Industrial Co-operation is currently inviting applications for the above-mentioned training missions in Japan financed by the European Commission. Called 'World Class Manufacturing', they are intensive 5-day training missions in Japan about improvement of productivity, assisting executives from EU manufacturing companies to acquire a better understanding of how Japanese companies continually eliminate costs from their manufacturing. This mission will provide participants with an ideal opportunity to visit some of the world's most advanced Japanese plants to understand the real "Gemba", (i.e. the production site), to talk directly with their production managers, and to observe how manufacturing methods are implemented effectively.

Two training dates for the missions are scheduled:

- Spring session from 29 June to 3 July 2009 (application deadline is 26 March 2009)
- Autumn session from 19 to 23 October 2009 (application deadline is 11 June 2009)

There is no tuition fee for SMEs.

PARTNERS' CORNER

The Sector Group on Services and Retail has produced some information documents on the provision of services in the Internal Market

The Sector Group has drafted an information package on the provision of services in the Internal Market for Newcomer colleagues in the Network. It has also produced two fact sheets, one of the posting of workers and the other on the provision of cross-border services by self-employed. These products are intended to help you better understand these issues in order to explain them to your SME clients.

Jitka Rysava, member of the Sector Group Services and Retail summarizes the main principles and requirements of the provision of services in the Internal Market:

The principles of the freedom to provide cross-border services in the Internal Market were laid down already in the EC Treaty in 1957. The basic rule is set down: such activities must be temporary (within the limited period of time, limited number of orders, etc.) and the activities have to be supplied also in the home country. Provision of cross-border services can be applied in two ways:

- By posted workers posting of workers.
- By self-employed provision of cross-border services by self-employed persons.

Beside the EC Treaty and the case law, the Directive on posting of workers 96/71/EC is applied. The Services in the Internal market Directive 2006/123/EC should be implemented by the end of the year 2009. The rules and procedures for temporary provision of services are guite complicated. The providers must for instance follow subsequent rules on:

- Social and health insurance
- Income taxes
- VAT
- Conditions avoiding social dumping
- Notification procedure
- Transitional period
- Qualification for profession regulated in the host countries.'
