

Dear Participant,

It is my great pleasure to invite you to the 10th CEI Summit Economic Forum (SEF) "Mobilising resources for a common future", which will take place in Sofia, on 20-21 November 2007, under the auspices of the Bulgarian Presidency of the Central European Initiative (CEI).

This year two major regional events - the Summit Economic Forum and the South-East Europe Forum, will join their efforts to provide a single platform for forward-looking discussions on the future business opportunities in CEI countries. The event will take place alongside the Roundtable of the Economic Ministers of the 18 CEI Member countries and will precede the annual CEI Summit of Heads of Government.

The SEF 2007 will bring together high-level representatives from the business community, governments, international financial institutions and other international organisations and will offer you the opportunity to exchange views on the most topical issues for our region.

This year's forum will hold panel discussions on energy infrastructure, energy efficiency, innovative credit lines for the residential sector; on the development of regional railway networks for support of the freight transport; on technical cooperation needs in the region and the ways and means for the international organisations and donor governments to respond to them; on SMEs, capacity building and ICT.

Going through this year's SEF programme, we introduced a special panel dedicated to business opportunities in Bulgaria. Over 1000 participants are expected this year. It is thanks to them that the SEF has become one of the most successful initiatives in the region.

The Central European Initiative (CEI) comprises 18 Member States. Membership extends over a territory of 2.4 million square kilometres with a population of nearly 260 million. From the very beginning, the main aim of the Initiative has been to help transition countries in Central and

Eastern Europe in their journey towards further integration with EU structures. Although the CEI is not a major donor organisation, it has several funds which are used to promote projects in a number of sectors. The accession of five CEI Member States to the EU in May 2004, and of Bulgaria

and Romania in January 2007, has shifted the CEI focus towards those Member States remaining outside the EU. By developing and implementing various projects and programmes, the CEI assists its Member States in a concrete and demand-driven manner.
