2. APPLICATION FOR PARTICIPATION

THE EXHIBITOR must fill in the Application Form and the attached registration card and send them to the Organizer than August 5 2011.

3. EXHIBITION VENUE AND TIMETABLE

The exhibition will take place at the National Palace of Culture - Sofia. The EXHIBITOR uses the hired exhibition area in the period 13 – 18 September 2011.

Working time for exhibitors: 9:30 h – 19:30 h

Visit hours: 10:00 h – 19:00 h

4. DELIVERY OF THE STANDS

In distributing and choosing the exhibition area for the stands, advantage will be given according to the order of receiving the applications.

The EXHIBITOR shall not transfer the entire or part of the hired exhibition surface area without the ORGANIZER's agreement. Written requests for rejection of participation shall be accepted not later than 30 (thirty) days before the opening of the exhibition. After this period the EXHIBITOR must pay a penalty fee of 300 EUR /20% VAT to be applied/.

5. HEIGHT AND WEIGHT LIMITS OF THE EXHIBITS

In case the exhibits exceed the height of the exhibition structure, special permission will be requested by the ORGANIZER. For bigger-size and heavy exhibits (more than 1000 kg) the exhibitors need the ORGANIZER's approval.

6. SPECIAL CONDITIONS AND SERVICES

THE EXHIBITOR shall inform the ORGANIZER about the presence of the sub-exhibitor companies represented by him. The EXHIBITOR shall not: bore holes into the panels of the stand structure; stick posters or other advertisements on the walls and pillars of the venue; distribute advertisement materials outside the stand; smoking in the venue except in the smoking area.

In case of infringements, the EXHIBITOR shall pay for the incurred damages.

If the stand is built by an external company, the EXHIBITOR shall pay a building tax of 2 EUR/sq.m/day for the time of mounting/demounting.

The ORGANIZER provides night security guard during the exhibition. The EXHIBITOR bears the risk and the responsibility for transport, storage and display of the exhibits and the stand material. To guarantee his/her interests, the EXHIBITOR has to insure its property against any risks. The materials, used for construction and exhibits arrangement must not be easily inflammable.

The EXHIBITOR pays additionally for the following services:

- Transport and forwarding;
- Handling operations of exhibits and stand material;
- Settlement of customs formalities, etc;
- Hotel and accommodation reservations;
- Presentation of firms;
- Individual advertisement of the company in the mass and specialized media;
- Cocktails and others.

In case of annulment or delay of the exhibition for force-majeure reasons, the ORGANIZER shall not be responsible before the EXHIBITOR for eventual damages.

7. CATALOGUE

The exhibition catalogue includes all exhibitors with their name, address and subject of activity in Bulgarian and English language. The companies are given the possibility to advertise in the catalogue (according to the tariff). The materials for the advertisement must be submitted to the ORGANIZER by 15th August 2011.

8. CONDITIONS AND TERM OF PAYMENT

The exhibitor is obliged to transfer onto BCCI's bank account: BIC code: UNCRBGSF, IBAN in EUR: BG20 UNCR 7000 1520 0699 29, UniCredit Bulbank AD, Business Center "Aksakov", str. "Aksakov" № 8, 1000, Sofia, Bulgaria in two stages: 40 % advance up to 20 days after signing the Application Form and 60 % - 10 days before the event. In case the sums have not been remitted within the time specified, the ORGANIZER has the right to cancel the participation.

9. OTHERS

1. The exhibitors are obliged to observe the General Conditions for participation.

2. All disputes arisen between the EXHIBITOR and the ORGANIZER shall be settled through negotiations. If no agreement is reached, the disputes will be referred to the competent Court, no matter whether the head quarters are abroad or in Bulgaria.

These GENERAL CONDITIONS are printed in Bulgarian and English language. Upon settling any disputes between the ORGANIZER and Bulgarian companies, the authentic text will be accepted in Bulgarian language, in all other cases – the text is in English.
