# GENERAL CONDITIONS

## FOR PARTICIPATION IN THE 13-th INTERNATIONAL SPECIALIZED EXHIBITION AND SEMINAR FOR SECURITY, SAFETY, PROTECTION

### SECURITY 2006

#### 1. ORGANIZER

**SECURITY 2006** is organized by:

#### 2. APPLICATION

The Exhibitor must fill in the present Application Form-Contract Agreement and the enclosed Registration Form and send them to the Organizer not later than December 30, 2005.

#### 3. LOCATION, HOURS

The exhibition will be held at the Main Building of the National Palace of Culture - Sofia. The exhibition halls are available to the EXHIBITORS from February 13 - 19, 2006.

Working hours - 9,30 - 19,30 h;

Visiting hours - 10,00 - 19,00 h.

#### 4. HANDING OVER OF SITES

The sites are to be handed over at the time fixed by the ORGANIZER. The exhibition space will be assigned in the order of the applications received.

The EXHIBITOR is not allowed to transfer the whole or part of the rented exhibition area without the ORGANIZER's consent. Written applications concerning size modification of the confirmed exhibition area or withdrawal from participation will be accepted not later than 30 (thirty) days before the Exhibition opening. After that term the EXHIBITORS should pay the full amount of the confirmed application regardless that they will not make use of the ordered exhibition area.

#### 5. RESTRICTIONS OF EXHIBIT HEIGHTS AND WEIGHTS

The ORGANIZER is asked for an authorization if the exhibits exceed the height of the exhibition construction. Weighty exhibits of overall dimensions above 1000 kg are to be agreed upon with the ORGANIZER.

#### 6. SPECIAL REQUIREMENTS AND SERVICES

The EXHIBITORS, representing other companies - sub-exhibitors should have them all registered for participation in the exhibition with the ORGANIZER.  
During the exhibition, the ORGANIZER ensures night shift security,

but he/she is not responsible when whole exhibits or parts of them are found missing.

The EXHIBITOR takes the risk and responsibility involved with transportation, storage and display of the exhibits and the stands. In order to have his interests protected and guaranteed, the EXHIBITOR has to take out insurance against all risks of his participation in the exhibition himself. No inflammable materials should be used with the stand construction and the arrangement. The ORGANIZER is obliged to give instructions on the necessary precautions against fire.

The ORGANIZER offers the following services:

- transportation and shipping services;
- forward and customs clearance;
- loading and unloading of the exhibits and stand material etc.;
- hotel reservations and accommodations;
- presentations;
- floral decorations;
- individual advertising campaign of the companies in the mass media;
- cocktail parties, etc.

If the exhibition is canceled or postponed as a result of force major or any other cause, the ORGANIZER will not be liable or responsible for any possible damages.

#### 7. CATALOG

A catalog of the exhibition will be published with an editorial listing of all exhibitors and products. It will also offer all exhibiting companies the opportunity to advertise. The advertising layout should be submitted to the Organizer till January 13, 2006.

#### 8. CONDITIONS AND TERMS OF PAYMENT

The EXHIBITORS are obliged to remit, not later than **January 20, 2006** the total fee for the area and the services ordered to the BCCI's bank account No 140 030 810-8 at BULBANK, code BFTBBSGF, 7, Sveta Nedelya Square, 1000 Sofia. In the event of payment outstanding, the ORGANIZER shall have the right to terminate the contract.

#### 9. CONCLUDING CLAUSE

All disputes between the EXHIBITOR and the ORGANIZER shall be settled through negotiations. If no agreement is reached, the disputes will be referred to the Court of Arbitration to the BCCI - Sofia, no matter whether the headquarters are abroad or in Bulgaria.

The Present General Conditions are to be printed in both Bulgarian and English languages. For settlement of the disputes between the ORGANIZER and the Bulgarian companies, the text in Bulgarian language should be considered as a reliable source; in all other cases, the English text should be considered as a reliable source; in all other cases, the English text should be considered as being true to the original.
