



The ATA Carnet is an international unified customs guarantee document for temporary importation, exportation and transit of goods under the International Convention ATA and the Istanbul Convention for temporary import. In compliance with the Bulgarian legislation the regime of its use in the Republic of Bulgaria is regulated by the Rules for the Application of the Customs Act.

The Republic of Bulgaria joined the Convention ATA in 1964, and its application began in 1967. Ever since, the BCCI has been the issuing and guaranteeing organization of ATA Carnets. On these grounds, the Chamber is a member of the International ATA Guarantee Chain, established with the World Chambers Federation.

The ATA Carnet applies to all countries that have signed the Convention, whereby the guaranteeing bodies are:

Advantages from the use of ATA Carnets

Procedure for issuance of ATA Carnets

In order to obtain an ATA carnet you have to:

- Fill-in all the required information and describe the goods in the unified forms.
- Sign a contract with BCCI for the issuance and guarantee of the carnet by the BCCI.
- Remit a deposit to BCCI. The sum may be paid in cash at the Chamber's cash-desk or remitted to BCCI's bank account.
- Pay the cost of the service for the issuance of the Carnet.

Carnets are processed and issued by BCCI within one day. After they are used up they have to be returned to BCCI.

Certificates of Origin of goods

BCCI is the only organisation in Bulgaria accredited by International Chamber of Commerce World Chamber Federation to issue Certificates of Origin

BCCI is authorized to issue non-preferential Certificates of Origin with Permit No. P-545 /32-204903/24.07.2017 of the Director of the Bulgarian Customs Agency, pursuant to Art. 16h, para 1 of the Customs Act of the Republic of Bulgaria

The Bulgarian Chamber of Commerce and Industry issues and certifies various documents assisting Bulgarian tradesmen in carrying out their foreign trade activities.

Certificates of origin of goods:

- 1. European Community Form.
- 2. Certificates of origin of goods Form "A", in compliance with the General System of Preferences (GSP).

Force-Majeure Certificates

In accordance with the international practice and in the capacity of an independent organization which is a member of the International Chain of Chambers of Commerce, ICC -Paris, Eurochambres - Brussels and other international organizations and institutions, the Bulgarian Chamber of Commerce and Industry issues Force-Majeure Certificates. The Force-Majeure Certificate is a document for relieving of responsibility for failure to perform one's obligations or delay in the performance of obligations under a transaction caused by some unpredictable circumstance.

Unpredictable (force majeure) circumstance is an unforeseen and irresistible event of emergency nature arisen after the conclusion of the contract, thus impeding its execution.

The Court of Arbitration at the BCCI Third Century in Serving to Business

Established more than 120 years ago (1897) as a Court of Conciliation at the Bulgarian Chamber of Commerce and Industry in Sofia the AC has heard and settled civil disputes between legal persons at least one of them being seated outside Bulgaria. Its jurisdiction was obligatory for the foreign trade enterprises from the states members of Comecon based on the Moscow Convention of 1972 and voluntary based on an arbitration agreement entered by the parties.

It began to act as a voluntary arbitration court between natural and/or legal persons domiciled, resp. seated in Republic of Bulgaria since 1989.

The Executive Bureau of the BCCI adopted Rules and Tariff for Arbitration "Ad hoc" Assisted by the AC at the BCCI on 17th of January 1989.

The Rules on Expedient Procedure in Arbitration Cases, applicable to domestic disputes of claim amount up to BGN 10 000, is in force as of 1st January 2005.

For the last 20 years only the Arbitration Court has settled about 5,600 cases, natural, resp. legal persons of 40 countries in the world being parties to them.

The latest amendments to the Rules of the AC at the BCCI are in force since 1st of February 2002.

Updated lists of arbitrators for international and internal disputes are in force since 1st of January 2005.


