EIC Accelerator

- Supports the **later stage** of technology development, technological readiness level TRL 5/6 or higher (deadline for Pathfinder was May 25, for innovations at an early stage);
- Supports **breakthrough** innovation in every area of technology and applications (budget € 592.5 million);
- In the area of addressing **global challenges** (EIC Accelerator Challenge), nearly 495 million euros are planned for breakthrough innovations with an impact on the Green Pact, economic recovery and digital and health technologies.

EIC Accelerator

FINANCING

Up to € 2.5 million for innovation development costs. From 500,000 to 15 million euros are provided in the form of capital investments.

Project proposals by filling in a short application form can be submitted at any time.

Full project proposal submission

The final dates for submitting the full package of documents announced for the Accelerator Open and Accelerator Challenge are set for June 16 and October 6, 2021.
