II. By signing this Application Form, I hereby DECLARE that:

1. The data included in the Registration Card enclosed to the application form for associated membership of the entity represented by me are up-to-date as of the date of filing of this Application Form.

2. The entity represented by me is not in liquidation.

3. The entity represented by me accepts BCCI's Articles of Association, BCCI's Code of Ethics in the Business Activity in the relations with its business partners, will be loyal to BCCI and will not undermine its authority.

4. As a direct member of BCCI, the entity represented by me would like to use:

a) the minimum package of services – annual membership fee of BGN 250;

- б) the standard package of services – annual membership fee of BGN 800;  
в) the extended package of services – annual membership fee of BGN 2 500.

5. Upon enrollment of the entity represented by me as a direct member of the BCCI, it will strictly do its duties, ensuing from the Articles of Association of the Chamber and will duly pay the required membership fee within the specified term. Non-compliance with the latter will be deemed as a reason for termination of the membership in compliance with Art. 19, para 1, item 2 of BCCI's Articles of Association.

III. I expressly give my consent to receive from BCCI its information bulletin, marketing and other messages, by checking the field:

IV. Information from BCCI regarding the administered personal data of the direct members in relation to the requirements of the General Data Protection Regulation (GDPR) (EU) 2016/679 (“the Regulation”):

- BCCI has undertaken all necessary actions and measures for the protection of the personal data it collects and processes in compliance with the requirements of the Regulation. - The personal data included in the Registration Card for membership (associated and direct) are processed on the grounds of performance of a requested and established membership relationship to which the data subject is a party, or in order to take steps at the request of the data subject prior to requesting and entering into a membership relationship (pursuant to Art. 6, para 1, letter “b” of the Regulation), and for the purposes of its legitimate interests (pursuant to Art. 6, para 1, letter “f” of the Regulation).
- BCCI administers the data (including personal data) included in the Registration Card in relation to the rights and obligations of the direct member under Art. 16, para 2 and Art. 17 of BCCI's Articles of Association, and in relation to the services which the member will use from BCCI, including services for the issuance and validation of documents which the member needs to certify the circumstances related to its business activity, the establishment of business contacts; the issuance of certificate with data from the Unified Trade Register of BCCI (in this case the direct member expressly states what data, including personal data, to be included in the document), etc.
- To guarantee the preciseness and actuality of the data, including of the personal data administered by BCCI, in addition to applying internal

mechanisms, BCCI requires and expects assistance from each member to inform it in due course about changes made in the data included in the submitted Registration Card. In addition to internal mechanisms for actuality of the data of the direct members, BCCI also applies policies/procedures for protection of the personal data, depending on the grounds for their administration.

- BCCI stores the data (including personal data) provided by the direct member until termination of the direct membership.
